The Public Authority is represented by Shri R.K.Saxena, PIO, Dr Rajesh Kumar, Deputy Registrar and Shri Harmeet Singh, Assistant Registrar.

The above parties were heard on video conference.

**FACTS**

The appellant vide his RTI dated 17.8.10 had sought copies of rules relating to attending of international conferences and related matters. The CPIO vide his letter dated 14.10.10 informed the appellant that information sought from Deputy Registrar, Administration, u/s 5(4) of the RTI Act, but no information has been received so far.

2. The appellant filed his appeal on 4.10.10. The AA vide order dt 8.11.10 expressed dissatisfaction with Deputy Registrar (Admn) and deemed PIO for not taking any action for two months and ordered him to provide information within ten days. His explanation was also sought for not taking any action on the application of the appellant for two months.

3. Not satisfied with the response, the appellant filed the present appeal.

4. The appellant submitted that in spite of the order of the AA, the Deputy Registrar and Deemed PIO Shri Aman Preet Singh provided information on 10.2.2011. He further added that the information provided is incomplete and no answer has been provided to his query no. 1,2,5,6,9 & 11. In respect of query no.10, the date provided is incorrect.

5. The PIO informs that the then Deputy Registrar, Shri Aman Preet Singh has left the Institute and is now working with Punjab Technical University, Jalandhar.

## **DECISION**

6. The Commission is of the view that the appellant shall be provided an opportunity on a mutually convenient time and date to examine various records and to take photo copies of the same. The appellant expressed apprehension that he may be harassed at the time of examination of files. The Deputy Registrar is directed to ensure that no such obstacles take place and a responsible officer is available at the time of inspection. As regards query no.10, the PIO is directed to verify the date and inform the appellant of its veracity or otherwise, in writing. The above action shall be completed within two weeks from the date of receipt of the order. The appeal is disposed of.
